Exhibition Committee - Shall Schedule All Exhibits and Shall Make All Physical Arrangements for the Exhibition, i.e.

Exhibition Committee_Jobs Needing to be filled and done:

- 1. Make arrangements for Location, dates, and hours of the Exhibition.
- 2. Shall Contract a Juror for the show, obtain a resume, and Make an agreement for the charges required by the juror.
- 3. Prospectus: Dates and Hours for Receiving, Reception, Pickup rejected/accepted work, Jurying, Hanging, Directions to the Exhibition location, Description of the requirements for accepted work to be organized for distribution.
- **4.** Receiving is in charge of entry forms, master list of current members, cash box, membership cards, furniture setup (if necessary), parking, open & close the gallery (where necessary), markers, pens, tape and scissors. Receiving is also in charge of pickup of rejected/accepted work at the designated times.
- **5. Telephone:** Volunteers to notify entrants of acceptance or rejection.
- **6.** Hanging: Arranges painting, exhibiting artist list, types cards for paintings, fills out ribbons, brings hammer, screwdriver, picture hooks, ladder or step stool where necessary.
- 7. Reception: Makes arrangements for refreshments according to the location, decorations, tables, cloths, clean up.
- 8. Publicity: Photographer, story, list of winners, get Entry info about the exhibition to the papers before and info about the exhibition to the newspapers before the Opening Ceremony.
- 9. The Exhibition Committee shall also
 - **a.** Purchase the award ribbons and obtain prizes
 - **b.** Give all monies to the treasurer with an accounting from where it has come and been spent (receipts)
 - c. Make sure all prize checks have been signed and placed in envelopes to be distributed at the Opening to the winners.
 - **d.** Make sure all paintings are picked up by the designated time unless other arrangements have been made with the committee.

The Responsibilities of the Committee are as Follows:


- **1. Contracting the Instructor,** arranging for the cost of instruction and anything else required by the instructor, plus obtaining a bio for the workshop outline.

- 5. Keeping Track of <u>All Monies</u> paid in/paid out. Keeping track of <u>ALL</u> receipts. Giving this money, receipts, and records of expenditures, etc, to the Treasurer when the workshop is over.
