ELIGIBILITY REQUIREMENTS

- APS Membership current for the "member year" the show occurs (18/19)(MUST JOIN OR RENEW BEFORE ENTRIES SENT TO JUROR OR SPECIAL MEMBERSHIP POINTS WILL NOT BE ACCRUED) Join or renew on APS Website http://www.appalachianpastelsociety.org/.
- 80% of the exposed surface must be dry pastel. No oil pastels.
- Size limitation 36" x 36", including frame. Over-sized work will not be hung.
- Must be entirely the work of the artist and not copied from other artists or publications
- Must not have been done under supervision (as in a workshop or class)
- Must not have been exhibited before in any juried APS show
- Not copied from published photos or from photos taken by others without permission
- Nudes and violent subjects not accepted to this show.
- Sales are encouraged, but paintings do not have to be for sale.

Luana Luconi Winner is a founding member of the Portrait Society of America, elected Master Circle member of the International Association of Pastel Societies, Signature Member of the Pastel Society of America, past president and honorary lifetime member of the Pastel Society of North Carolina, an active member of several art boards and national art organizations.

Portrait artist, author, lecturer, judge, and favored instructor, Mrs. Winner was educated in Rome, Florence, Switzerland, and the USA. Her portraits of CEOs, Banking Founders, Chancellors, Administrators, Government Officials, Military Officers, Debutantes, and families hang in corporations, universities, government buildings, museums, and residences stateside and abroad.

Luana was guest instructor for the international pastel exhibition "Pastel en Perigord," France, worked in Spain, and then followed with a two-person exhibition in Tuscany, Italy. She was part of the first Chinese pastel festival at Ming Art Gallery in Suzhou, China and traveled as part of a cultural exchange of art instructors. Her book "Painting Classic Portraits: Great Faces Step-by-Step" in English and Chinese, a textbook for drawing and painting faces, is published/distributed worldwide by F+W Media.

 - o 300 dpi, 1200 pixels on longest side [contact managers if you need help with image sizing]
 - Naming of files... LastnameFirstInitial_Title_ImageSizeHxW.jpg [So, for an artist named Bruce Jones submitting a painting with a title of Morning Sky with an unframed size of 15 inches high and 22 inches wide, the name of that file would be, JonesB_MorningSky_15x22.jpg]
 - o Images must not show mat, frame, etc., and must be an accurate representation of the artwork
- If you need help with any of the entry, please call one of the show managers...we are happy to help!

PRESENTATION OF ARTWORK

- Framed under glass or acrylic
- If mats used, must be white or off-white. Paintings with colored mats will be hung, but not judged.
- Ready to hang with flat hooks and strong wire. No saw-tooth hangers.
- APS reserves right to refuse any painting that does not meet professional gallery standards

DELIVERY AND PICKUP

- Delivery and pickup details sent with acceptance. Shipping cost and liability is artist's responsibility.
- Entrants failing to deliver accepted work will be denied eligibility to APS shows for 2 years.

SALES

- Work does not have to be for sale. Please mark "NFS" and current market value for insurance.
- Price may not be changed after submission
- No Commission on sales (Voluntary 20% donation to Grace recommended by APS Show Committee.)
